
**MOTION FOR AN EXTENSION OF TIME WITHIN WHICH  
TO INTERVENE AND MAINTAIN SEAL OVER SECOND AMENDED COMPLAINT**

For good cause shown, the United States of America respectfully requests that the Court extend the *qui tam* seal in this action to allow the United States to obtain Department of Justice approvals to notify the Court at the next deadline of how the United States will proceed. The United States seeks an extension of the seal, through and including March 11, 2013. Counsel for Plaintiff Relator has authorized the United States to represent to the Court that he does not object to the requested extension. Additional plaintiffs, the States of California, Florida, Illinois, Massachusetts, Minnesota, Montana, Nevada, North Carolina, and the District of Columbia concur in the request presented here.

WHEREFORE, the United States of America, and the other parties plaintiff, move for an extension, through and including March 11, 2013, in which to intervene. The United States further asks that the Court maintain the seal in this matter, except as otherwise already ordered by the Court, through that same date.
